YOUR TELNO 68 : ILLEGAL LANDING ON SOUTH GEORGIA

1. I CARRIED OUT THESE WELCOME INSTRUCTIONS WITH COSTA MENDEZ AT 2045Z THIS EVENING. HE WELCOMED YOUR UNDERSTANDING OF AND RESPONSE TO HIS PREOCCUPATIONS AND SAID THAT WE, THE DIPLOMATS, WERE NOW ENGAGED IN A MATTER OF CRISIS MANAGEMENT IN WHICH THE FIRST STEP HAD NOW BEEN TAKEN. HE HAD BEEN IN CONTACT WITH THE JUNTA AND WAS JUST ABOUT TO ENTER A MEETING WITH CERTAIN MILITARY REPRESENTATIVES AND WOULD GIVE ME SOME RESPONSE TO YOUR PARA 2 LATER THIS EVENING. I SAID THAT, IN ESSENCE THE SITUATION WAS THAT THE MEN MUST GO, TRANSPORTED EITHER BY US OR BY THE ARGENTINES. HE AGREED THAT THIS MEANT THAT AN ARGENTINE REMOVAL NEED NOT NECESSARILY INVOLVE THE BUEN SUCESO ITSELF AND I SUSPECT THERE MAY BE SOME OTHER FORM OF TRANSPORT ENVISAGED. MEANWHILE, THE MINISTER CONTINUED, THE OTHER PART OF CRISIS MANAGEMENT WAS HANDLING THE PRESS. WE AGREED THAT HERE IN BUENOS AIRES AT LEAST NOTHING MORE WOULD BE SAID THAN THAT SUCH AND SUCH MEETINGS HAD TAKEN PLACE AND THAT CONTACT CONTINUED.
