- 1. COSTA MENDEZ TELEPHONED ME YESTERDAY EVENING TO SAY THAT HIS MESSAGE TO YOU WOULD BE READY AT \$93\$ (123\$\psiz\$) TODAY AND I HAVE JUST COLLECTED IT. OUR TRANSLATION OF FULL TEXT IS IN MY IFT. IN ESSENCE IT SAYS THAT WE ARE MAKING TOO MUCH FUSS OVER A MATTER IN ADMITTEDLY DISPUTED TERRITORY SEMI COLON THAT THE ARGENTINE GOVERNMENT CANNOT BUT TAKE THE PRECAUTIONS REQUIRED BY PRUDENCE AND ITS RIGHTS AND THAT THE WORKMEN SHOULD CONTINUE ON SOUTH GEORGIA SINCE THEY HAVE THE NECESSARY DOCUMENTATION.
- PHRASE MEANT THAT, IN THEIR VIEW (AND ROS WAS ONE OF THE NEGOTIATIONS) SOUTH GEORGIA IS (REPEAT IS) INCLUDED IN THE WHITE CARD REGIME BY THE 1971 AGREEMENT.
