1. ON RECEIPT OF YOUR TUR I SUMMONED STREATOR (THE US AMBASSADOR IS ABSENT). I SPOKE TO HIM PRIVATELY AND MADE IT CLEAR THAT I WAS UPSET BY THE ATTITUDE REFLECTED IN WHAT STOESSEL HAD SAID: IT REALLY WAS RATHER ODD TO SEE OURSELVES PUT ON THE SAME FOOTING AS THE ARGENTINE. STREATOR TOOK THE POINT AND SAID THAT HE WOULD REPORT. I SAID THAT I DID NOT WANT TO MAKE TOO MUCH OF THIS, BUT POINTED OUT THAT WE HAD DONE MUCH TO SUPPORT THE UNITED STATES OVER THE PAST YEAR OR SO (INCLUDING THE SINAI INFO AND SENDING OBSERVERS TO EL SALVADOR) AND MY MESSAGE TO HAIG OVER SOUTH GEORGIA HAD BEEN THE FIRST TIME I HAD ASKED FOR HELP FROM THE UNITED STATES.
