





SECRETARY-GENERAL HAS MAINTAINED CONTACT WITH THE PERMANENT REPRESENTATIVES TO THE UNITED NATIONS OF BOTH PARTIES. HE HAS ALSO FOLLOWED CLOSELY THE EFFORTS CURRENTLY BEING MADE BY THE GOVERNMENT OF THE UNITED STATES IN PROVIDING ITS ASSISTANCE TO THE PARTIES WITH A VIEW TO FACILITATING A PEACEFUL RESOLUTION OF THE DISPUTE IN THE CONTEXT OF THE SECURITY COUNCIL RESOLUTION. 
