2. COSTA MENDEZ IS MEETING WITH THE JUNTA (21:55 HRS) ON WHAT HIS OFFICE DESCRIBED TO ME AS THE "DISTURBING NEWS FROM LONDON" (THE STATEMENT FROM NO 10). I SENT YOUR LETTER TO COSTA MENDEZ IN THE MEETING BY THE SAFE HAND OF HIS PRIVATE SECRETARY.
3. THE QUESTION NOW ARISES AS TO WHAT YOU WOULD WANT ME TO DO WHEN HE COMES BACK, AS HE IS PERFECTLY CAPABLE OF DOING, TO PLEAD MISUNDERSTANDING AND ASK TO GO OVER THE TEXTS. MY INCLINATION WOULD BE TO GIVE HIM OURS AND TO SAY THAT I AM NOT, RPT NOT, AUTHORIZED TO DISCUSS IT FURTHER.
