

- -- IN THAT REGARD YOU SHOULD BE AWARE THAT IF ARGENTINA CANNOT ACCEPT THE PROPOSAL AND FULL-SCALE FIGHTING BEGINS, AS SECRETARY HAIG TOLD YOU, IT WILL BE POLITICALLY IMPOSSIBLE FOR THE U.S. ADMINISTRATION TO AVOID PROVIDING VARIOUS TYPES OF ASSISTANCE TO THE UNITED KINGDOM.
