2. AFTER EXAMINING THE PROPOSAL SEPARATELY WITH THEIR STAFFS, THE THREE MEMBERS OF THE JUNTA ARE NOW SCHEDULED TO MEET AT THE CASA ROSADA AT 2030 HOURS LOCAL. THEY WILL BE THERE CONSIDERING THEIR RESPONSE WHICH I STILL HOPE TO GET BEFORE MIDNIGHT TONIGHT.

3. CONFIRMING THE REPTELCON, OUR IMPRESSION IS THAT THE NAVY HAS BEEN RESISTING FURTHER "MEDIATION" EFFORTS BY THE SECRETARY. THAT SERVICE'S MOUTHPIECE, "CONVICCION," HEADLINED A STORY TODAY, "THE EX-MEDIATOR WOULD COME WITH AN ULTIMATUM" (SEE SITREP). THIS OF COURSE, REFERS TO YESTERDAY'S ACTIVITIES IN WASHINGTON AND NOT TO THE PROPOSAL I SUBMITTED THIS MORNING. SO FAR THERE HAS BEEN NOTHING IN THE MEDIA HERE ABOUT THE LATTER.
