9	1. I rang Haig at 1700Z.
10	2. Haig said that Costa Mendez had refused to see him. His
11	impression was that the Argentinians were trying to buy time,
12	and to secure changes from the British end. I said that there
13	could of course be no question of this. Haig said that this
14	was fully understood. He intended to brief the Senate this
15	afternoon and to go much further than he had yet done in indica-
16	ting that there was no question where the problem lay, in that
17	the Argentinians were reacting negatively to proposals that
18	were already asking less of them than of the British. He would,
19	however, not go so far as to rule out any resumption of US
20	activity in promoting a negotiated settlement for the future. I
21	said that the Argentinian position ^{was} is beginning to look very
22	like a refusal of the American proposals. Haig said that if
23	their answer was no, so be it.
