SITUATION IN THE SOUTH ATLANTIC

The Sub-Committee had before them memoranda by the Secretary of State for Defence (OD(SA)(82) 3) and the Secretary of State for Foreign and Commonwealth Affairs (OD(SA)(82) 2) and a minute of 6 April to the Prime Minister from the Secretary of the Cabinet (A08060).

THE PRIME MINISTER, summing up the discussion, said that the United States Secretary of State, Mr Haig, wished to visit London that day. It should be explained to him that Ministerial preoccupation with the Parliamentary debate made this impossible but that he would be very welcome the following day, on the basis that he would not come as a potential mediator but as a friend and ally of the United Kingdom. The Sub-Committee would meet in the course of the evening to decide whether in his winding up speech in Parliament the Defence Secretary should announce that a 200-mile Exclusion Zone would be established round the Falkland Islands with effect from midnight on 11/12 April; if so, the terms of the announcement would need careful consideration, as would the possibility of informing Mr Haig in advance.

The Government were likely to be asked during the Parliamentary debate whether the task force was carrying nuclear weapons. The reply should be that, in accordance with precedent, nothing could be said in public about the whereabouts of British nuclear weapons in any circumstances; but that there was no possibility in the present context of any kind of nuclear weapons being used. Further consideration would need to be given to the Rules of Engagement to be observed by British forces involved in the crisis, and in particular to the possibility of authorising any attack on Argentine naval vessels outside the proposed Exclusion Zone. Meanwhile the Royal Navy's nuclear submarines and the Task Force should remain on course for the Falkland Islands. Planning could proceed for a possible operation to recapture South Georgia; and further consideration would be given to the possibility of arranging for the Governor of the Falkland Islands to join the Task Force on its way south.

The Sub-Committee

1. Invited the Secretary of State for Foreign and Commonwealth Affairs to inform the United States Secretary of State that he would be very welcome to visit London the following day, on the basis indicated by the Prime Minister in her summing up.
2. Instructed the Secretary of the Cabinet to arrange for the drafting of a possible form of words for announcing the establishment of an Exclusive Zone round the Falkland Islands.
3. Invited the Secretary of State for Defence to handle any questions about nuclear weapons on the lines suggested by the Prime Minister in her summing up.
4. Agreed to resume their discussion at 7 pm that evening.

SITUATION IN THE SOUTH ATLANTIC

The Sub-Committee had before them memoranda by the Secretary of State for Defence (OD(SA)(82) 3) and the Secretary of State for Foreign and Commonwealth Affairs (OD(SA)(82) 2), a minute of 6 April to the Prime Minister from the Secretary of the Cabinet (A08060) and a note by the Secretaries (OD(SA)(82) 4).

THE PRIME MINISTER, summing up the discussion, said that the Sub-Committee were clear that an Exclusion Zone of 200 miles should be established round the Falkland Islands. The question of when this should be announced and take effect was more difficult, and various possibilities had been carefully considered. On balance, it seemed that the wisest course would be to announce before the end of the Parliamentary debate that evening that the Zone would be established from midnight on 11/12 April; and to inform the United States Secretary of State, Mr Haig, before the announcement. The announcement should be in the terms of the draft attached to OD(SA)(82) 4, subject to two minor amendments in the third sentence: "all" should be replaced by "any"; and "entering or" should be deleted.

The Sub-Committee

1. Invited the Defence Secretary to announce, in the course of his winding-up speech in the current Parliamentary debate, the establishment of the proposed Exclusion Zone on the basis indicated by the Prime Minister in her summing up.
2. Invited the Foreign and Commonwealth Secretary, at his discretion, to inform the United States Secretary of State of this announcement before it was made.
3. Invited the Foreign and Commonwealth Secretary, in consultation with the Defence Secretary, to arrange for the establishment of the Exclusion Zone to be formally notified, after the announcement and in identical terms, to overseas governments and other interested parties.
4. Agreed to resume their discussion at 11 am the following day.
