SITUATION IN THE SOUTH ATLANTIC

Previous Reference OD(SA)(82) 2nd Meeting

The Sub-Committee had before them a note by the Secretaries (OD(SA)(82) 5) setting out draft Rules of Engagement for British submarines in the crisis area; and a minute of 8 April to the Prime Minister from the Foreign and Commonwealth Secretary (PM/82/26) about nuclear weapons on board ships of the Task Force for Operation Corporate.

THE PRIME MINISTER, summing up the discussion, said that the proposed Rules of Engagement were acceptable. The commanding officer of a submarine would naturally have the right to exercise his discretion in any matter relating to the safety of his vessel. The Sub-Committee sympathised with the Foreign and Commonwealth Secretary's proposal

In their

meetings with the United States Secretary of State, Mr Haig, that evening, she and the Foreign and Commonwealth Secretary and the Defence Secretary would make clear that the immediate requirement was for Argentine troops to leave the Falkland Islands and for British administration to be restored; thereafter, Britain would be willing to resume negotiations with Argentina; but she would be guided by the wishes of the islanders, which could clearly not be ascertained in present circumstances. Further thought would need to be given to the diplomatic and political options which might be possible in the future; and she would consider, in consultation with the Foreign and Commonwealth Secretary, whether a full-time Special Adviser should be temporarily appointed for this purpose.

The Sub-Committee -

1. Approved the Rules of Engagement for British submarines proposed in OD(SA)(82) 5.
2. Took note with approval of the approach suggested by the Prime Minister for the forthcoming discussions with the United States Secretary of State.
