## 1. MILITARY ISSUES

THE CHIEF OF THE DEFENCE STAFF briefed the Sub-Committee on the latest military situation.

The Sub-Committee -

Took note.

## 2. POLITICAL ISSUES

The Sub-Committee had before them telegrams nos. 832-3, 835-6, 839-40 and 842-4 from the British Representative at the United Nations, Sir Antony Parsons, reporting on the current situation in the Security Council; and telegrams reporting the position in the European Community and the attitude of the United States and others.

THE PRIME MINISTER, summing up the discussion, said that of the various possible Resolutions now being canvassed at the Security Council, the Irish and Panamanian drafts would certainly have to be vetoed. The Japanese draft could only be accepted if it omitted reference to the Secretary General's previous efforts, which had now been overtaken by events, and if it included a specific call for an Argentine withdrawal as well as a cessation of hostilities. The non-aligned states' revised version of the Irish draft could be accepted provided that the second operative paragraph read

"Requests the Secretary General, on the basis of the present resolution, to undertake a renewed mission of good offices in accordance with Security Council Resolution 502."

There should be no reference to the Secretary General's statement of 21 May. If possible, the third preambular paragraph should also be omitted. In explanation of vote Sir Antony Parsons should make clear that in Britain's view an Argentine withdrawal would be the only acceptable basis for a ceasefire.

The Sub-Committee -

Invited the Foreign and Commonwealth Secretary to instruct Sir Antony Parsons in accordance with the Prime Minister's summing up.
