YOUR TELEGRAM NO 84 : FALKLANDS CRISIS, PRECAUTIONARY MEASURES

1. WE HAVE ALREADY STARTED DESTRUCTION OF ALL SENSITIVE MATERIAL PRIOR TO 1981 AND, MORE RECENTLY, OF HIGHER SENSITIVITY. WE EXPECT TO COMPLETE THIS OPERATION INCONSPICUOUSLY WITHIN 18 HOURS OR IN LESS TIME IF IT BECOMES APPROPRIATE TO USE INCINERATOR IN THIS SMOKELESS ZONE. I EXPECT TO DISCUSS MESSAGES TO THE BRITISH COMMUNITY WITH PRESIDENT OF THE BRITISH COMMUNITY COUNCIL LATER THIS AFTERNOON, BUT DO NOT ANTICIPATE THAT ANY RADICAL MEASURE WILL BE REQUIRED. SIMILARLY, WHILE WE ARE PREPARING CONTINGENCY PLANS, I WOULD HOPE THAT, EVEN IF DIPLOMATIC RELATIONS ARE BROKEN, MOST EMBASSY AND BRITISH COUNCIL STAFF WILL BE ABLE TO REMAIN. GRATEFUL FOR EARLIEST INDICATION WHOM YOU WOULD ASK TO REPRESENT UK INTERESTS SHOULD DIPLOMATIC RELATIONS BE BROKEN.
