PATIENCE AND STATESMANSHIP YOU HAVE DISPLAYED OVER THE
PAST TWENTY-FOUR HOURS. THE EXTREMELY UNHELPFUL PRESS
STORIES AND PUBLIC SPECULATION ABOUT THE TALKS HAVE BEEN
A BURDEN TO ALL OF US, BUT ESPECIALLY TO YOUR GOVERNMENT.
HOPEFULLY ALL PARTIES INVOLVED IN THIS DELICATE AND
DANGEROUS SITUATION WILL BE ABLE TO AVOID FEEDING OR
OVERREACTING TO MISCHIEVOUS PRESS STORIES IN THE COMING

DAYS. I AM CONVINCED THAT SOME OF THESE ARE ENCOURAGED,
IF NOT PLANTED, BY THE SOVIETS IN THE HOPES OF DERAILING
