1. AS AGREED IN TELECON HEAD UN DEPARTMENT/FAULKNER WE GAVE THE HEAD OF PEREZ LLORCA'S PRIVATE OFFICE OUR REASONS WHY THE SPANISH RESOLUTION WOULD BE UNACCEPTABLE TO US (2ND TUR).

2. HAVING IN MIND THE TIME FACTOR AND THE NEED TO HELP ITS AUTHORS UNDERSTAND WHY THE SPANISH RESOLUTION WAS INADEQUATE, I GOT IN TOUCH WITH THE HEAD OF UN DEPARTMENT AT THE SPANISH MFA ON RECEIPT OF YOUR FIRST TUR. I ASKED WHETHER PINIES HAD REPORTED ON OUR DRAFT RESOLUTION. NOT SURPRISINGLY HE HAD NOT DONE SO. I THEREFORE TOOK CASAMIRANDA THROUGH IT, STRESSING THAT THE TEXT WAS NOT TO BE TABLED BUT ILLUSTRATED THE KIND OF CEASEFIRE WE WERE READY TO CONTEMPLATE. HE WELCOMED THIS ACTION BUT MADE NO COMMENT OF SUBSTANCE. IN REPLY TO A QUESTION ABOUT ITS FOURTH OPERATIVE PARAGRAPH, I DREW CASAMIRANDA'S ATTENTION TO POSSIBLE DOUBTS ABOUT THE ARGENTINIAN COMMANDER'S ATTITUDE TO A CEASEFIRE (PARAGRAPH 4 OF MADRID TELEGRAM NO. 309).
