LETTER DATED 14 JUNE 1982 FROM THE CHARGE D'AFFAIRES A.I. OF  
THE PERMANENT MISSION OF ARGENTINA TO THE UNITED NATIONS  
ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL

On express instructions from my Government, I have the honour to inform you of the following communiqués issued by the Joint General Staff of the Argentine Armed Forces:

Communiqué No. 156 of 13 June 1982

"The Joint General Staff announces that during the night and until 1200 hours today, 13 June 1982, the following events took place in the Malvinas area:

1. There were no infantry confrontations.
2. Artillery fire was slight.
3. Argentine Air Force aircraft attacked The Two Sisters area.
4. It is supposed that the enemy's inactivity is due to the great effort made yesterday, which has obliged him to replenish his resources for resumption of the attack.
5. Our own forces are reordering their defences and are ready to go into action."

Communiqué No. 157 of 14 June 1982

"The Joint General Staff announces that combat action yesterday, 13 June 1982, was as follows:

1. The Argentine Air Force made various attacks on enemy personnel and matériel, and various strikes were effected against land vehicles, personnel, helicopters and containers.

2. The enemy artillery fired on the Argentine artillery, which responded with concentrated fire, which had evident results, particularly on The Two Sisters and Mt. Harriet. This action was maintained throughout the day.
3. During the afternoon between 1530 and 1600 hours, British troops tried to advance on Mt. Harriet; our artillery repulsed them and forced them to protect themselves with smoke-screens and withdraw. Later, intense efforts by British helicopters to remove their casualties from the terrain were observed."

Communiqué No. 158 of 14 June 1982

"The Joint General Staff announces that, at 2230 hours yesterday, 13 June 1982, British forces resumed their attack at three points on the combat front, using large amounts of resources.

There was generalized fighting for possession of Tumbledown Mountain and Wireless Ridge, involving the infantry and artillery of both sides.

So far, the Argentine forces are containing the attack and maintaining their positions."

The military actions of the Argentine armed forces described above have been carried out by the Argentine people and Government in exercise of the right of self-defence provided for in Article 51 of the Charter of the United Nations.

I request that this letter be distributed as a document of the Security Council.
