OPERATION CORPORATE

ITEM 1. INTELLIGENCE

1. SIR TERENCE LEWIN invited the Deputy Chief of the Defence Staff (Intelligence) to update them on current intelligence.

2. LIEUTENANT GENERAL GLOVER (Deputy Chief of the Defence Staff (Intelligence)) reviewed the intelligence published in the latest summary (1). He said that Aerospatiale had confirmed that they had supplied only 5 air-launched EXOCET missiles to Argentina. The further 5 ordered by Argentina had not been delivered, nor the 2 ordered by Peru. He had also received technical advice that the sea-launched EXOCET missile could not be converted for air launching.

ITEM 2. OWN FORCES

3. The Task Force organisation was set out in the Force Tote Sitrep (2).

4. The operations of the previous 24 hours had been summarised in the television briefing preceding their meeting.

5. In discussion the following points were made:

a. If HMS SHEFFIELD were to sink or be sunk, careful consideration would need to be given to the timing and content of any announcement.

b. The first 2 Nimrod aircraft modified for air-to-air refuelling should be operational at Ascension Island on 9 May, and a further 2 aircraft 2 days later.

6. In discussion it was agreed that aircraft accidents should be reported through operational channels and not peacetime administrative channels. All such reports were to include a recommendation from the Task Force Commander on the timing and content of any announcement.

ITEM 3. PUBLIC RELATIONS

7. MR McDONALD (Deputy Chief of Public Relations) reported on press coverage.

8. In discussion the point was made that we were in danger of losing the public relations war. It was essential that the goodwill of the press, and in particular of our accredited defence correspondents, was retained. Steps should be taken urgently to improve the situation; such measures might include:

- a. The adoption of a more positive attitude to the rapid release of factual information.
- b. The provision of routine reports from the Task Force Commander at a greater frequency, for the better information of the Defence Public Relations Staff when dealing with queries.
- c. The provision of facilities for background briefing by Service specialists on matters of topical interest such as the conversion of merchant shipping for Service use, and the modifications to aircraft to enable air-to-air refuelling to be carried out.
- d. The nomination of a panel of experts, approved by the Ministry of Defence, who would be given background briefings in depth, and who would then be available to make authoritative comment when required.
- e. The relaxation of restrictions on reporting our activities at Ascension Island, particularly when Argentine prisoners of war were being repatriated.

9. Summing up, SIR TERENCE LEWIN said they would wish to agree that urgent measures should be taken to improve our relations with the press, and that he and the Permanent Under Secretary together should investigate the setting up of a suitable panel of experts. They would wish to invite the Service Departments to make factual reports more readily available, and to provide background briefings on any suitable topic by Service specialists. They would also wish to agree that the restrictions they had imposed on reporting from

Ascension Island should be relaxed, and that the Deputy Chief of Public Relations should, in consultation with the Permanent Under Secretary and the Foreign and Commonwealth Office, make proposals for greater publicity of our activities on the island. Finally, they would wish him to discuss further with the Task Force Commander the possible provision of more frequent reports on operations, with a view to improving the speed and accuracy of our press releases and answers to questions.

ITEM 4. ACTIONS AND DISCUSSIONS REQUIRED

10. The Committee noted the summary of action in hand (3).
11. In discussion the point was made that Rules of Engagment were urgently required for use by surface ships against Argentine commercial aircraft conducting surveillance. These should, if necessary, be handled separately from the main Rules of Engagement package (4).
12. Summing up, SIR TERENCE LEWIN said they would wish to instruct the Assistant Chief of the Defence Staff (Operations) to bring forward to him immediately after their meeting the proposed Rules of Engagement for use against Argentine commercial aircraft, for him to seek OD(SA) approval.
